### **Childcare subsidy application for 2019 (Application due January 31st 2020)**

GSOC-UAW and New York University are pleased to announce a childcare subsidy program has been created for eligible GSOC-UAW graduate employees. The childcare subsidy program grows from \$90,000 in 2019 to \$100,000 in 2020, and is apportioned based upon number of eligible applicants.

The subsidy is available to those GSOC employees who meet all of the following eligibility criteria:

- Must have held a GSOC-UAW Local 2110 bargaining unit position in calendar year 2019
- Must be a parent or guardian of one or more children under the age of six years old.
- Must have expenses associated with the child care of one or more children under the age of six years old.

To apply, please fill out this form and attach:

1. a copy of your appointment letter for one semester of work in a Union position
2. proof of birth, such as a copy of your child's birth certificate
3. the attached affidavit, signed, proving your guardianship of the child.

- **Graduate students (Master’s/Ph.D.) who teach classes or have appointed teaching assistantships or laboratory assistantships (except Ph.D. student adjuncts beyond the 7th year and MBA candidates at Stern)**
- **Appointed Ph.D. research assistants (with exceptions at Tandon and GSAS sciences)**
- **Graduate & Course Assistants (with exceptions at the School of Medicine)**
- **Graduate student workers in a range of miscellaneous positions, who are employed by NYU**
